<u>Item 5 – Discussion, Consideration and Action – BIM25-01 – Informational Memorandum – Year 2025 9-1-1 District Operational Review</u>

The 9-1-1 District Administration announced the appointment of two key roles. Sharla Allison to the role of 9-1-1 District Division Manager and Rebecca Mortensen to the role of 9-1-1 Program Coordinator. These individuals will be dedicated 100% to the operations of the 9-1-1 District.

# <u>Item 7 – Discussion, Consideration and Action Regarding – BR25-03 – Resolution – FY25</u> <u>Budget Revisions</u>

There was a review of revenue analysis, proposed expense revisions, and proposed new rates for the remainder of FY25. Discussion regarding the revenue trends and anticipated changes to wireless and wireline fees. A recommendation was made by Administration of a rate change of \$1.85 for residential and \$16.00 for business/trunk lines to sustain the fund balance to maintain dispatch reimbursement at its current rate. Details were given on the expenses and the changes from FY24 to FY25. Swanson explained the need to increase funds to facilitate the need for GIS services through a contract with RDI. Marjorie Knight, Director of Finance for the City of Abilene, detailed how indirect cost expenses are figured for the 9-1-1 District.

Boardmember Rice motioned to accept the staff recommendations on expenses and the proposed rate changes from \$2.00 to \$1.85 for residential and \$17.80 to \$16.00 for business. Boardmember Pope seconded the motion. Motion Carries.

# <u>Item 8 – Discussion, Consideration and Action Regarding – BR25-04 – Resolution – FY2026</u> Proposed Budget

There was an overview of proposed expense revisions and proposed new rates for the remainder of FY25. It was determined more time would be needed to run reports based off the rate changes accepted in BR25-03 and a proposed special meeting to discuss this item once District Administration could create new reports with changes to revenue and expenses. This would also provide more time for the District Administration to meet and discuss changes to the dispatch reimbursement with Taylor County Administration and City of Abilene Administration and bring that information back to present to the Board.

Chairman Bush motioned to table BR25-04 until the next meeting. Boardmember Rice seconded the motion. Motion carries.

<u>Item 9 – Discussion, Consideration and Action Regarding – BIM25-03 – Informational</u> Memorandum – Long Range Financial Plan (LRFP)

A presentation that included a concept model of the Long-Range Financial Plan (LRFP) with the idea of presenting this LRFP as an actionable agenda item in the next board meeting. This plan would cover a five-year period with decreasing wireline revenue (lowering the wireline rates) while also decreasing the funds allocated to 9-1-1 Dispatch reimbursement. This plan will, however, require meetings with the City of Abilene and Taylor County Administration to discuss shifting the responsibility of the dispatch reimbursements to those respective parties.
